### **Tumbler Machines (Front Loading):**

Light soil: use 60-90 mL (2-3 oz) per 45 kg of linen.

Heavy soil: use 120-180 mL (4-6 oz) per 45 kg of linen.

### **Agitator Machines (Top Loading):**

Light soil: use 30-60 mL (1-2 oz) per 45 kg of linen.

Heavy soil: use 60-120 mL (2-4 oz) per 45 kg of linen.

**Effects of Acute Exposure to Product:** Product exposure may irritate eyes. Prolonged or repeated exposure to skin may cause dryness. Inhalation of vapors or mists is unlikely because of product use. Ingestion may cause gastrointestinal and abdominal discomfort.

## SECTION 7 – PREVENTATIVE AND CONTROL MEASURES

**Respiratory Protection:** Not required for normal use of product.  
**Ventilation:** Good general ventilation or local exhaust ventilation for spraying and misting in confined areas.  
**Protective Gloves:** Normally not required. However, wearing of rubber gloves are recommended to minimize skin dryness from prolonged or repeated skin contact.  
**Eye Protection:** Normally not required. However, wearing of safety goggles are recommended if there is a risk of product splashing into eyes during usage.  
**Protective Clothing and Equipment:** Eyes wash recommended in the immediate work area.  
**Storage and Handling Procedures:** Use good Industrial hygiene. Avoid contact with skin, eyes and clothing. Store in a cool, dry place away from incompatibles. Keep container closed when not in use. Do not mix with other chemicals. Store at temperatures below 30°C and keep from freezing.  
**Disposal Procedures for Spills or Leaks:** Wear protective equipment. Dike and contain large spills. Pump spills into an approved waste container. For small spills, soak up with a suitable absorbent such as clay, soil or commercially available absorbents, and then dispose of into an approved waste container. Keep away from sewers and natural waters.  
**Waste Disposal Method:** Reuse if possible. Otherwise dispose recovered material in accordance with all local, Provincial or Federal regulations.  
**Special Shipping Information:** Store at temperature below 30°C. Keep from freezing.

## SECTION 8 – EMERGENCY FIRST AID PROCEDURES
